Blacklisting of the firm i.e M/s Landis+Gyr Limited, Kolkata on account of supply of inferior quality of HT consumer meters & HT Feeder Meters to DHBVN in respect of Rate Contract no. RC-235/QD-738/XEN/MM dated 03.03.2017 & RC-234/QD-739/XEN/MM dated 03.03.2017 respectively.

Rate contract No. RC-235/QD-738/XEN/MM dated 03.03.2017 & Rate contract No. RC-234/QD-739/XEN/MM dated 03.03.2017 were placed upon M/s Landis+Gyr Ltd., Kolkata for supply of 8922 Nos. (Max) HT CT/PT Operated consumer meters & 6252 Nos. (Max) HT CT/PT Operated feeder meters respectively for UHBVN and DHBVN. The POs were placed by the

Against RC-235, DHBVN issued PO No.DH-1477 dated 21.03.2017, DH- 1615 dated 11.12.2017 and DH-1802 dated 08.02.2019 for supply of 2700, 2748 & 724 No. meters respectively. Against Rate Contract No. RC-234, PO No.DH-1478 dated 21.03.2017, DH- 1614 dated 11.12.2017 and DH-1692 dated 11.06.2018 were placed for supply of 2750, 1500 & 552

Your firm has supplied the material against all the above POs.

After receipt of meters against PO No. DH-1477 & PO No. DH-1478 and their installation in the field offices of DHBVN, M&P wing of DHBVN observed erratic behavior of HT Feeder meters & HT consumer meters, simultaneously.

Subsequently, the matter was discussed on 27.11.2018 in the chamber of the Director/Projects, DHBVN, Hisar, wherein the representative of your firm stated that erratic behavior of the HT Meters (Feeder meter & consumer meter) has been indentified due to faulty lot of capacitor mounted/installed in the Power Supply Portion of these meters. It was further submitted by representative of your firm that the aforementioned faulty capacitor were installed only in 1st lot (i. e. P.O. No. DH-1477 & PO No. DH-1478) of HT consumer meters & HT feeder

It was also assured by representative of your firm that in the 2<sup>nd</sup> lot (PO No. DH-1614 & PO No. DH-1615), such fault does not exist and an undertaking in this regard was also submitted by your firm vide letter ref. no. L+G/DHBVN/HTTVM/AM/301118-4 dated 30.11.2018.

In view of the above, following decisions were taken and communicated to your firm vide MM office memo no. Ch-29/DH-1477/QD-738 dated 24.12.2018 and memo no. Ch-उत्तर प्रदेश पावर कारपोरेश 310H-1477/QD-738 dated 22.01.2019:-

1- The lot be rejected and bidder may be asked to arrange to supply the replacement within forty-five (45) days at his cost including to and fro transportation. In addition to this, a penalty @ 5% of cost of the rejected lot of material be imposed. The rejected material shall be lifted back by firm only after replacement with fresh material.

2- Cost of replacement of meters, data analysis and any other expenditure on these activities shall be borne by M/s L&G. The O/O CTO, DHBVN, Hisar will intimate the cost of said

The payment against cost of these 5450 No. defective meters (2700 Nos against PO No.DH-1477 & 2750 Nos against PO No.DH-1478) be withheld from pending payments of the firm till replacement of these meters (already accrued/ to be accrued).

In case of 2748 no. HT consumer meters supplied by your firm in respect of 2<sup>nd</sup> PO (DH-1615) placed against rate contract No. RC-235/QD-738/XEN/MM dated 03.03.2017, M&P wing of DHBVN intimated that after analysis of data/load survey of Meter Sr. no. 80223371, it was found that meter remained in sleep mode (Power off). The reading of meter Sr. no. 80223246 was also found to be reset. The meter was also displaying wrong date of MDI. Similar case of sleep mode (Power off) was also detected in another meter bearing Sr. no. 80222635 by M&P team of Gurgaon Division of DHBVN.

From the above, it is evident that defects like, meter going in to sleep mode, reading reset & displaying wrong MDI date were observed in 2 no. lots of meters (supplied by your firm against PO No. DH-1477 & PO No. DH-1615). In the analysis report submitted by your firm w.r.t UHBVN observations, your firm accepted that "when external device/Magnetron device is applied on the meter, they also observed data corruption either with application of external device/Magnetron or if a similar condition is generated by a rapid glitch/spike came at power up.

However, such type of data corruption is not desirable at all, even with application of external device/magnetron and thus proves malfunctioning of these meters. Moreover, from your firm's reports, it was observed that your firm was still hiding some manufacturing defects which led to abnormal behavior of meters supplied by your firm.

To reach at logical conclusion, M&P wing of Nigam asked your firm to visit DHBVN office on 1.01.2020. Data observed by the Nigam was shown to your firm's representative but your firm reiterated your previous stance as in DHBVN & UHBVN. Your firm was also given opportunity to come with your technical team on 3.01.2020 and 5.01.2020 but no representative of your firm attended said meeting.

Due to observance of erratic behavior of HT CT/PT Operated consumer meters & Feeder meters (particularly the meters going in sleep mode and displaying wrong readings) the Nigam has suffered financial loss and reputation as well. As such, it was decided to terminate RCs/POs placed upon your firm and charge/recover penalties/LD charges accordingly. Notices were issued to your firm vide MM office memo no. Ch-105/DH-1477 dated 02.04.2020 & memo no. Ch-67/DH-1478 dated 15.04.2020 w.r.t HT Consumer meters & HT Feeder meters respectively intimating that:-

1. All the 6472 No. HT CT/PT Operated consumer meter supplied against PO No. DH-1477, DH-1615 & DH-1802 (RC-235/QD-738/XEN/MM dated 03.03.2017) and all the 4802 No. HT CT/PT Operated Feeder meters supplied by the firm against PO No. DH-1478 dated 21.03.2017, DH- 1614 dated 11.12.2017 and DH-1692 dated 11.06.2018 (RC-234/QD-739/XEN/MM dated 03.03.2017) are hereby rejected and cost of these 6172 No. HT consumer meters and 4802 No. HT CT/PT Operated feeder meters shall be recovered from the firm.

 Cost of replacement of 61\(\text{V2}\) no. HT CT/PT Operated consumer meter & 4802 No. HT CT/PT Operated feeder meters including data analysis and any other expenditure on these activities shall be recovered from the firm.

 A penalty @ 5% of value of 6172 no. HT consumer meters & 4802 No. HT Feeder meters shall be recovered from the firm due to Non -- conformance of material with provisions of technical specification as per clause no. 14(x) of schedule-D of NIT documents.

4. Purchase Order No. PO no. DH-1477 dated 21.03.2017, PO No. DH-1615 dated 11.12.2017 & PO No. DH-1802 dated 08.02.2019 and PO no. DH-1478 dated 21.03.2017, DH- 1614 dated 11.12.2017 and DH-1692 dated 11.06.2018 placed upon the firm for supply of HT Consumer meters & HT Feeder meters respectively are hereby terminated on account of supply of inferior quality.

Liquidated damages (L.D.) charges @ 5% of cost of the un-delivered material i.e. 6172
 No. HT CT/PT Operated consumer meter & 4802 No. HT CT/PT Operated feeder meters shall be recovered from the firm as per clause no. 9 "Supplier's default liabilities" of the POs/ RC.

6. A show cause notice of 21 days is being issued upon the firm as per provision in clause no. 13 (corrupt or fraudulent practices) and clause no. 17 (blacklisting of firms) of the RC No. 235 dated 03.03.17 & RC No. 234 dated 03.03.17 that why the firm should not be blacklisted on account of supply of inferior quality of material to the Nigam.

In response of the above, your firm submitted reply vide your letter ref. no. L+G/ DHBVN /RC-235/SK/21042020-1 dated 21.04.2020 in respect of HT consumer meters & vide letter ref. no. L+G/DHBVN/RC-234/SK/05052020-1 dated 05.05.2020 in respect of HT Feeder meters. While considering the reply submitted by your firm, Competent Authority observed that your firm has failed to deliver good quality material as per contract agreement due to which Nigam has suffered financial loss as well as work of replacement of defective meters and release of new connections was delayed. Thus, by supplying inferior quality of HT consumer meters & HT Feeder meters, your firm has failed to adhere to its contractual obligation to supply good quality material which tantamounts to breach of contract. Hence, the reply given by your firm was

The above details were considered by the Whole Time Directors of DHBVN in their meeting held on 05.06.2020 and decided to recommend the case to BODs for blacklisting of your firm i.e M/s Landis+Gyr Ltd. Kolkata for a period of three years on account of supply of inferior quality of HT Consumer Meters & HT Feeder Meters.

Subsequently, your firm filed a civil writ petition No 8794 of 2020 in the Hon'ble 2 Court Punjab and Haryana at Chandigarh in which your firm prayed for quashing of letters dated 02.04.2020 & 15.04.2020 (i.e notice of blacklisting & recoveries of penalties/LD Charges issued by MM office of DHBVN in case of HT consumer meters & HT Feeder meters offering depositing penalties/ recoveries imposed by DHBVN) and refraining the Nigam from blacklisting or

The matter was decided by Hon'ble Punjab & Haryana High Court, Chandigarh on 30.06.2020. The matter was disposed off with a direction to consider reply to Show Cause Notice and if necessary, the opportunity of hearing be given before passing any order against the

As per direction of Hon'ble High Court dated 30.06.2020, an opportunity of hearing was given to your firm by BODs of DHBVN in its meeting held on 30.12.2020. In meeting of BODs, your firm submitted letter dated 30.12.2020 & put up brief facts in support of your case.

Relevant provisions of the contract are reproduced below for reference:-

Clause No. 4 of Rate Contract (Warranty):

The supplier shall be made responsible to replace free of cost, with no transportation or insurance-cost to the Nigam, up to the destination, the whole or any part of the material which in normal and proper use proves defective in quality or workmanship, subject to the condition that the defect is noticed within 66 months from the date the material is received by the consignee or 60 months from the date of installation which ever period may expire earlier. The consignee or any other officer of the Nigam actually using the material will give prompt notice of each such defect to the supplier as well as the Purchasing authority and the Controller of Stores. The replacement shall be effected by the supplier within a reasonable time, but not, in any case, exceeding 45 days. The supplier shall also arrange to remove the defective supply within a reasonable period but not exceeding 45 days from the date of issue of the notice in respect thereof, but only after replacement of defective material. Upon the firm failing to do so, the damages/defects may be got rectified by the Nigam and the cost adjusted from the firm's pending dues and/or security deposit against this or any other contract in force and the balance left be got deposited by the supplier. The Nigam may also withhold the amount equal to cost of

The warranty for 66/60 months shall be one time. In addition to above, warranty should be extended by the supplier for the period for which the service was not rendered by the material/equipment supplied by the supplier which would be allowable for one occasion only. In case of recurrence, the material/ equipment shall have to be replaced afresh or cost of the material shall be recoverable from the pending liabilities of the supplier/contractor towards

After completion of overall warranty period, if it is found that any material defective/ damaged within warranty period is still lying in the store/field/with the firm then equivalent amount of cost of material as BG shall be accepted. After receipt of fresh BG, the old BG should be

In case of breach of contractual obligations with reference to non responding for repairing /replacement of defective material, notices of 15 days & 21 days shall be issued to the firm and in case of still persistence of default, the Nigam shall reserve the right to terminate the contract, encashment of BG towards recovery of damages and further initiation of action for blacklisting.

Clause No. Clause 14(x) of schedule-D (TESTS AND INSPECTION):

Non – conformance of material with provisions of technical specification: – The material offéred/received after the inspection by the authorized inspecting officer may again be subjected to the test for losses or any other parameter from any Testing House/in-house technique of the Nigam & the results if found deviating, un-acceptable or not complying to approved GTP, the lot shall be rejected and bidder shall arrange to supply the replacement within forty-five (45) days of such detection at his cost including to and fro transportation. In addition to this, a penalty \$\omega\$ 5% of cost of the rejected, lot of material shall be imposed. The rejected material shall be lifted back by firm only after replacement with fresh material or by submission of additional BG of equivalent to the cost of material. This BG shall be released when the replacement of material with fresh material received in the Nigam Stores and material is accepted by the Nigam.

Clause No. 9 of Rate Contract (Suppliers & Default Liabilities):

In the event of breach of any these terms and conditions by the supplier, the purchaser can terminate the contract without Notice to the supplier at any stage and the supplier shall have no claim whatsoever on the purchaser on this account. But the supplier shall be liable to pay to the purchaser a sum equivalent to 5% of the value of the undelivered material as liquidated damages and not as a penalty.

> Clause No. 8 of Rate Contract (Set-Off):

Any sum of money due and payable to the supplier under the contract (including Security deposit returnable to the supplier) may be appropriated by the purchaser and set-off against any claim of the purchaser for the payment of a sum of money arising out of or under this contract or any other contract entered into by the supplier with the purchaser.

Clause No. 13 of Rate Contract (Corrupt or Fraudulent Practices):

The Nigam requires that Tenderers/ Suppliers/ Contractors observe the highest standard of ethics during the procurement and execution of Nigam contracts. In pursuance of this policy, the Nigam:-

(a) Defines, for the purposes of this provision, the terms set forth as follows:

 Corrupt practice means the offering, giving, receiving or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution: and

- (ii) Fraudulent practice means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the Nigam, and includes collusive practice among Tenderers (prior to or after tender submission) designed to establish tender prices at artificial, non-competitive levels and to deprive the Nigam of the benefits of free and open competition;
- (b) will reject a proposal for award if it determines that the Tenderer recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question;
- (c) will declare a firm ineligible, either indefinitely or for a stated period of time, to be awarded a Nigam contract if it at any time determines that the firm has engaged in corrupt or fraudulent practices in competing for, or in executing, a Nigam contract.

Clause No. 14 of Rate Contract (TERMINATION OF CONTRACT FOR DEFAULT):

The purchaser may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, terminate the contract in whole or in part:

- a) If the supplier fails to deliver any or all of the stores within the time period(s) specified in the contract, or any extension thereof granted by the Purchaser; or
- b) If the supplier fails to perform any other obligation under the contract within the period specified in the contract or any extension thereof granted by the purchaser.
- c) If the supplier, in the judgment of the purchaser has engaged in corrupt or fraudulent practices in competing for or in executing the contract (The definition of corrupt or fraudulent practices defined under clause-13).

In the event the purchaser terminate the contract in whole or in part. Available EMD submitted by the firm/supplier shall be forfeited and available BG shall be got encashed towards recovery of LD Charges and any other dues from the firm.

Clause No. 17 of Rate Contract (Blacklisting of the firm):

As the purchase order becomes a valid contract between the purchaser and supplier on the date of its issue, no further changes in the terms and conditions thereof are permissible and any request received in this regard from the supplier should be summarily rejected, making it clear to supply the goods strictly in accordance with the terms and conditions of the contract. it should be noted that such a liability can be enforced on the supplier only if the purchase order does not contain any term or condition contrary to what had been quoted in the supplier's tender. Once this is ensured, any attempt by the supplier to back out of his commitment should be taken seriously and his earnest money deposited be forfeited forthwith, without prejudice to any further legal remedies open to the Nigam under the relevant laws. Where necessary, the case of supplier illegally backing out of the commitment, should also be put up to the Board of Directors for consideration and to decide for black-Procedure for Blacklisting of firm

In case the supplier intends to illegally back out of the commitment, the steps for blacklisting of the firm, besides enforcement of damages recoverable under the law will be taken as per procedure given below:-

a) A notice shall be served by the purchasing department on the supplier by registered post/speed post bringing his defaults to his notice and asking him to complete all pending supplies / or to settle dispute within a period of 15 days from the date of issue of Notice.

b) In case the firm fails to comply with the notice(s), a show Cause notice of 21 days shall be issued why the firm/supplier/contractor should not be blacklisted. In the Show Cause Notice complete details of the case, default committed by the firm/supplier/contractor and details of notices issued by the Nigam shall be incorporated.

c) In case the supplier/firm/contractor falls to comply with the notice issued for blacklisting or does not respond to show cause notice or the reply as submitted is not found justified/convincing. The contract with the firm/supplier shall be terminated inter-alia taking other action as per regulation no. 20 & further the firm may be blacklisted with the

d) The period of blacklisting of the defaulting firm/ supplier/contractor will be approved upto 3 years by BOD's and shall be notified to all Power Utilities in the country and the names of such blacklisted supplier/contractor would also be put on the website of the Nigam

As per Clause No. 13(c) of rate contract No. 235 dated 03.03.17 (Corrupt Fraudulent Practices), the Nigam requires that Tenderers/ Suppliers/ Contractors observe the highest standard of ethics during the procurement and execution of Nigam contracts. In pursuance of this policy, the Nigam will declare a firm ineligible, either indefinitely or for a stated period of time, to be awarded a Nigam contract if it at any time determines that the firm has

engaged in corrupt or fraudulent practices in competing for, or in executing, a Nigam contract.

Your firm submitted false undertaking on 30.11.2018 stating that 2nd lot (Purchase Order) of the meters will have no defect. Trusting your firm, replacement of 1st lot (Purchase Order) of defective meters was allowed to your firm. In the meantime, meters received against 2nd lot (Purchase Order) were used for replacement of defective meters installed at consumer premises. Subsequently, it was observed that 2nd lot of meters was also having similar technical defects as were observed in 1st lot of meters. As such no option was left with the Nigam other than replacing L&G Make meters with other Make meters. By submitting analysis reports of defective meters, your firm tried to mould the case in its own way misguiding UHBVN & DHBVN which is a breach of trust and required to be treated as fraudulent practices

These meters were installed at the premises of high end consumers which is the major source of revenue to the tune of rupees in Crores, for UHBVN & DHBVN. Defects such as erratic behavior of meters or going in to sleeping mode (Non recording of energy even on running supply) are the defects which came in to notice only after through checking of site & detailed analysis of the data. Hence, such defects may lead to loss of crores of revenue of the Nigam.

As explained in above para, representative of your firm was well aware of such defect in the meters already supplied by your firm & also usability of HT meters but, choose to give false undertaking.

Due to casual approach of your firm, besides having financial loss, DHBVN has suffered loss of reputation also. Hence, your firm is liable to be punished under above mentioned

The above case has been considered by Board of Directors of DHBVN in its meeting held on 28.09.2021 and it has been decided to blacklist your firm i.e M/s Landis+Gyr Ltd. Kolkata for a period of three years from the date of issuance of communication.

This is however prejudice to other terms & conditions of the ibid contract.
