Please refer to this office memo no Ch-34/L-414//P&D/D-I dated 17.05.2018 & Ch-41/L-414//P&D/D-I dated 15.06.2018 vide which notice of Blacklisting were served upon to your firm. As per postal deptt., no such person of your firm were found at the address given by you in the documents submitted at the time of bid submission. However, the above notices have also been delivered on your email i.e. hip.delhi@yuhoo.com. But after affording ample opportunity to your firm, no reply has been received from your side in this office.

In this context, it is re-iterated that the work of Supply & Erection of material, testing and commissioning of New 11 KV lines with ACSR and ABC alongwith Pole mounting distribution substations with DTs of 25/16 KVA capacity for proving HVDS covered under NCR scheme of Rewari distt. (in 74 no. villages) Under Bawal in Narnaul circle on turnkey basis against tender enquiry no. P&D/TED-101/2008/Pkg-C was allotted to your firm vide Letter of Award dated 02.05.2009 and the work was allotted to be completed within 12 (twelve) months from the date of issuance of Letter

addition to above, the work of meter relocation was also allotted to your firm by the O. the then SE/Const. Faridabad vide work order no. 10/W.O./2011-12 dated 05.07.2011. But your firm completed the HVDS & meter relocation work only in 38 villages out of allotted 74 no. villages and despite various correspondences & notices, your firm did not complete the original work allotted against TED-101/Pkg-C as well as the additional work. Subsequently, in spite of various correspondences made by field offices, your firm did not take any interest to replace / repair the damaged material i.e. AB cable, distribution transformers etc.

As such, due to observance of poor performance on the part of your firm & despite affording ample opportunities to complete the above work, the contract with your firm was terminated on 30.01.2014. Consequent upon termination, it was also decided to encash the Bank Guaranttee amounting to Rs. 1,93,51,000/- submitted by the firm. But in the process of encashment of BG, it came to the notice of DHBVN that there was no Bank premises on the address given on the BG submitted by your firm. Consequently, DHBVN wrote a letter to the Bank authorities for confirmation of BG submitted by the firm. The Trade Desk Branch of HDFC Bank, New Delhi intimated that the BG submitted by your firm had not been issued by their Bank and hence was noted to be fake.

As your firm had not completed the allotted work as well as it was involved in corrupt & fraudulent activities as detailed above.

In view of above facts, the following penal clauses of the contract/ tender documents are invoked:

Clause no. 54:- Corrupt or fraudulent practices

The Nigam requires that Tenderers /Suppliers/Contractors observe the highest standard of ethics during the procurement and execution of Nigam contracts. In pursuance of this policy, the Nigam:-

- a) Defines, for the purposes of this provision, the terms set forth as follows:
 - (i) "Corrupt practice" means the offering, giving receiving or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution: and
 - (ii) "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the Nigam, and includes collusive practice among tenderers (prior to or after tender

levels and to deprive the Nigam of the benefits of free open competition;

- will reject a proposal for award if it determines that the Tenderer recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question;
- c) will declare a firm ineligible, either indefinitely or for a stated period of time, to be awarded a Nigam contract if it at any time determines that the firm has engaged in corrupt or fraudulent practices in competing for, or in executing, a Nigam contract.

Clause no. 57:- Blacklisting of the Firms:

The contractor will be blacklisted,

- If the contractor backs out of the contract at any stage, the firm will be issued two 15 days notices to commence the work failing which no further notices will be issued and the firm will be straightway Blacklisted, without prejudice to other terms and conditions of the contract.
- If the firms include in fraudulent and illegal practices such as forgery, cheating or any civil/criminal wrongdoing or any grave misconduct of similar nature which
- has a direct impact on the contract and the Nigam. In such case no notice of default will be issued and the firm will be straightway blacklisted in addition to initiating the legal proceedings etc., without prejudice to the other terms and conditions of the contract.
- 3. If the contractor fails to complete the work within the delivery/completion schedule, the deduction of the penalty will commence as per the terms and conditions of the present Bid Documents. On deduction of the complete penalty as admissible, the contractor will be issued one 15 days notice to complete the work failing which the Performance Bank Guarantee will be forfeited. Subsequent to the above two 15 days notices will be issued and the firm will be blacklisted thereafter.

The Performance Bank Guarantee of the Blacklisted firms will be forfeited and the firm shall have no claim whatsoever on the same.

However, Procedure and other conditions of contract are regulated by procurement manual of DHBVN, so, these will be applicable to the contractor as per procurement manual of DHBVN and amendments thereof from time to time.

Keeping in view of above facts, your firm i.e. M/s New India Power, Flat no.80, Pocket-12, Sector-22, New Delhi is hereby blacklisted as per clause no. 54 & 57 of bid

documents, for cheating & indulging in corrupt & fraudulent practices mentioned in the foregoing paragraph.

This is however without prejudice to other terms & conditions of the contract.
