

Blacklisting for a period of 3 years, on account of failure of sample in Shriram Institute for Industrial Research, New Delhi against Purchase Order no. DH-1548/RC-129/QH-II/1946/XEN/MM-I dated 09.10.2017 and on account of non- supply of material in Purchase Order no. DH-1548/RC-129/QH-II/1946/XEN/MM-I dated 09.10.2017 & DH-1561/RC-126/QH-II/1945/XEN/MM-I Dt. 12.10.2017.

Rate Contracts no. RC-129/QH-II/1946 dated 22.09.17 for supply of LT XLPE AB_Cable of size 3/Cx95+70 sq. mm (min. quantity 13.5 km. & max. quantity of 20 km.) and RC-126/QH-II/1945 dated 22.09.17 for supply of LT XLPE AB Cable of size 3/Cx120+70 sq. mm (min. quantity of 10 km. & max quantity of 15 km.) were placed upon your firm. Accordingly, PO no. DH-1548 dated 09.10.17 and PO no. DH-1561 dated 12.10.17 were issued for supply of 20 km. of LT XLPE AB Cable of size 3/Cx95+70 sq. mm and 15 km. of LT XLPE AB Cable of size 3/Cx120+70 sq. mm.

As per clause No. 2 "Delivery Period" of the POs, your firm was required to supply the material as per below mentioned lot-wise delivery schedule:-

In the 1st instance your firm supplied 5 Kms. LT XLPE AB Cable of size 3/Cx95+70 mm2 against PO no. DH-1548. The sample was got tested from Shriram Institute for Industrial Research lab, New Delhi and it got failed in testing on 16.05.18, due to nonconformance to relevant ISS & Nigam's Technical specification. Besides it, after pre-dispatch inspection at the works of your firm on 27.04.2018, DI for supply of 15.015 Kms. of LT XLPE AB Cable of size 3/Cx95+70 Sq. mm (pertaining to 2nd to 4th lots) was issued vide MM office memo no. Ch-46/DH-1548/RC-129 dated 08.05.18. Your firm did not supply the material પ `|૧against ibid dispatch instruction in spite of consistent follow-up by this office. The contractual delivery period of ibid PO has already expired on 23.02.18. As such, the quantity of 15 Kms. left un-delivered by your firm against PO no DH-1548

Likewise, against aforementioned PO no. DH-1561 dated 02.05.18, your firm failed to supply LT XLPE AB Cable of size 3/Cx120+70 mm2, even after offering material for inspection.

Accordingly, a notice of 15 days was served upon your firm vide this office memo no. Ch-60/DH-1548/RC-129/QH-II/1946/XEN/MM-I dated 14.09.2018, asking to complete all pending supplies against both the POs. But no response was elicited from your firm. As such, a show cause notice of blacklisting for 21 days, was issued vide this office memo no. Ch-61/DH-1548/RC-129/QH-II/1946/XEN/MM-I dated 26.10.2018. Your firm did not respond against the ibid show cause notice as well.

From the above position, it is clear that even after constant pursual, your firm did not come forward for supply of balance quantity of ordered material against the ibid Rate Contracts/POs and even did not bother to respond against two number ibid notices issued in this regard. Thus it is quite evident that your firm has failed miserably to fulfill its contractual obligations under the said contracts.

Accordingly, the case was put up before WTDs of DHBVN and it was decided to terminate the ibid POs after imposing penalties as per terms and conditions of the Purchase Order (s)/Rate Contract (s)/NIT inter-alia recommendation of blacklisting of your firm to BODs (Board of Directors) of DHBVN. The same was communicated to your firm vide this office memo no. Ch-67/DH-1548/RC-129/QH-II/1946/XEN/MM-I dated 08.02.2019.

In pursuance to ibid recommendation of WTDs, an agenda was put up before BODs of DHBVN in its meeting held on 07.03.2019 for seeking approval on blacklisting of your firm on account of above default. The Board of Directors considered the memorandum and approved the proposal.

Accordingly, your firm M/s Grid India Power Cables Pvt. Ltd. having Works and corporate office at Plot No. 63, Sector-5, IMT, Manesar, Gurugram-122050 (Haryana) is hereby blacklisted for a period of 3 years (from the date of issuance of communication).
