Dear sir,

As you are aware that tender was invited for procurement of 20 Nos., 12.5MVA, 33/11kV Power Transformers against tender specification no. CCP-II/28/2020-2021. That clause no (iii), (iv) of PQR and clause no 20 of the tender specification reads as under:

(iii) Operational experience:-

Performance certificate of at least 20% of the tendered quantity of 10MVA, 33/11kV power transformers or power transformers of higher capacity to the effect that the same has given three years proven trouble free service. The manufacturer shall provide performance certificate for the same issued from Govt. department/ Govt. undertaking/ SEB's / Power Sector Utilities.

(iv) Type Test:-

The offered transformer must have been fully type tested only from Govt. approved/NABL accredited testing laboratories as per relevant ISS and /or any other specified international standards, during last 5 years period to be reckoned from the date of opening of the tender.

In case the bidder does not have the valid type test report of 12.5 MVA, 33/11kV Power Transformer then the Part-II (Price Bid) of the bidder will be opened subject to condition that in the event of award, bidder has to summit valid type test report within 3 months from the date of LOI, however the approval of GTP & Drawing shall done after valid type test is provided by the bidder, failing which additional Security submitted by firm as प्रबन्ध निरमुख्यात्रात्र against timely providing of type test report, shall be forfeited.

Clause no. 20 of tender specification (Performance Security Deposit): The contractor shall deposit performance security @ 10% (Ten percent) of the F.O.R. destination price of material Including all taxes mentioned in P.O. in the form of bank draft, FDR / CDR or Govt. interest bearing security duly pledged in favour of Executive Engineer, Electricity Store Division, UPCL, Dehradun...

In case where bidder is participating in the tender without valid type test report of 12.5 MVA Power transformer and in the event of award to such bidder, the bidder shall mandatorily provide additional security @ 5% (Five percent) of the F.O.R. destination price of material including all taxes mentioned in P.O. in the form of the first percent. of the F.O.R. destination price of material Including all taxes mentioned in P.O. in the form of bank draft, FDR / CDR or Govt. interest bearing security duly pledged in favour of Executive Engineer, Electricity Store Division, UPCL, Dehradun within 7 days from the date of LOI in addition to performance security @ 10% (Ten percent) of the F.O.R. destination price of material Including all taxes mentioned in P.O. in the form of bank draft, FDR / CDR/BG or Govt. interest bearing security duly pledged in favour of Executive Engineer, Electricity Store Division,

UPCL, Dehradun which is required before executing the contract. The Additional security shall remain valid for 3 months from the date of issue with claim period of one month

Both the above mentioned securities are required for the execution of agreement.

The additional 5 % security deposit shall be released after the submission of valid type test report within the

If the contractor fails to provide the valid Type test report within 3 months, UPCL shall forfeit the additional security @ 5 % of the contract value and UPCL shall be at liberity to initiate any or all of the following proceedings against

The transformer required to be fully type tested, however firms were permitted to participate in the tender without a valid type test report subject to the conditions mentioned above.

- In pursuance to the Uttarakhand State purchase preference policy no. 1542 dated 20.08.2019, Counter offer, on L1 rates, was placed to you vide LOI no. 154 dated 22.05.2021.
- That acceptance of the counter offer was informed vide your letter no SIIL/UPCL/CCP-II/28/2021-21/130 dated 26.05.2021.
- You had submitted the additional security @5% for Rs 15,35,000/- vide your letter no. SIIL/UPCL/21-22/027 dated 05.08.2021(received on 12.08.2021).
- The due date for submission of type test reports expired on 22.08.2021 and response was sought from you vide this office letter no. 637 dated 07.09.2021 in reply to which you had vide letter no. SIIL/UPCL/CCP-II/28/21/213 dated 08.09.2021 requests UPCL to extend the date of submission of type test reports and assured that the said reports shall be submitted by 20.10.2021.
- The reasons forwarded by you were nor satisfactory neither acceptable as per the agreed terms and conditions.
- Moreover, you yourself stated to provide the said report till 20.10.2021 which also you failed.
- Although as per the agreed terms and conditions, the time extension for submission of type test report could not be sought, the response was sought from you on default to analyze severity of your conduct for the purpose of taking further action apart from forfeiture of the additional security, your failure to honour even the assurance given in your letter and also the reasons and justification given for the failure, cleary demonstrate your lameness of excuse and willful default, which requires strict action.
- That the clause no B(4) of counter offer dated 22.05.2021 clearly provides as under:
 - " The valid type test report of 12.5 MVA, 33/11KV Power transformer has to be submit within 3 months from the date of LOI, however the approval of GTP & Drawing shall be done after submission of valid type test, failing which additional security submitted by firm as guarantee against timely providing of type test report, shall be forfeited."

Further, clause B(6) provides as under:

"All other terms and conditions shall be as per tender specification no CCP-II/28/2020-21 and amendment therof, if any."

- It is regretted that the type test reports have not been submitted till date, due to which the material is not made available to UPCL and is a clear breach of the settled terms and conditions, hence constraining UPCL for invoking of clause no 20 as mandated in tender.
- Therefore as per Clause 20(amended) of General Requirement of specification of tender specification no. CCP-II/28/2020-2021.following actions are being taken against you.
 - The Additional 5% Security of Rs 15,35,000.00 shall be forfeited.
 - The LOI/counter offer date 22.05.2021 stands cancelled.
 - (iii) M/s Svasca Industries shall be barred from participating in future tenders of UPCL for all types of transformers for a period of one year.
