Further, you have also submitted your physical offer Sagainst the said tender (TS-1532) as per the provisions of the tender specification.

On scrutiny of the techno-commercial offer of your firm, the supporting documents regarding NABL accreditation of the lab was not found submitted along with the offer and therefore, as per practice, the query letter was issued to your firm vide this office No.MD/WZ/06/PUR/ TS-1532 / 10321 dt.29.07.20 1 specifically mentioning at point No. (v), that "Type test certificate issued by CPRI Bangalore No. 0344EATDBT16S0589 to S0597 dated 21.12.2016 has been submitted. For confirming NABL accreditation of the lab, following document(s) needs to be submitted.

NABL accreditation certificate of the testing lab (i.e. CPRI Bangalore) as on the date of issuance of type test certificate (i.e. 21.12.2016) issued by NATIONAL ACCREDITATION BOARD for TESTING and CALIBRATION LABORATORIES, for conducting test on BATTERIES."

In response, you have submitted a request (through your mail id: tejabatteries@gmail.com) to provide time to submit the related documents on 10.08.2021, and later on, vide your letter No.AKJ/TB/2021-22/MPMKVVCL/15729 dt.09.08.2021 (received through inward no.17853 on dated 17.08.2021), you have specifically mentioned that "NABL sites providing the status of last 02 years and to confirm it that this laboratory is NABL accredited or not at that time is not possible. So our request is that please be check it and grant us the permission to participate in the mentioned tender."

Hence, the matter was referred to the concerned lab i.e. CPRI Bangalore vide this office letter No. MD/WZ/06/PUR/TS-1532/11685 Indore dated: 24.08.2021 and in response, the CPRI Bangalore vides their letter No. CPRI/QAC/MPPKVVCL/21-22/01/REPORT VRFN Dated 04.09.2021, intimated that "It is hereby confirmed that the test report bearing the No.0344EATDBT16S0589 to S0597 is not issued by the concerned laboratory to the customer: M/s Teja Batteries Indore. The testing was not carried out by the concerned laboratory (EATD), CPRI, Bangalore for the customer: M/s Teja Batteries Indore. Further, it is confirmed that "the laboratory has not issued such test report for the customer: M/s Teja Batteries Indore. Also the stationary and the contents of submitted test report were fabricated. Hence the test report submitted is found to be a fake test report".

Thus, it confirms that, you have submitted a **fabricated and fake test report** of CPRI Bangalore for gaining advantage by way of fraudulently meeting the qualifying requirements of the tender specification No.1532 (opened on 16.07.2021) which clearly is an act of cheating with the purchaser i.e. adopting of unethical / unfair / fraudulent practice as against your specific notarized undertaking / Declaration given duly sealed and signed by Shri Vijay Kumar Jain as proprietor of M/s Teja Batteries Indore, submitted on non-judicial stamp paper against the prescribed Schedule-IX of the TS-1532.

Therefore, before initiating action for blacklisting of your firm M/s Teja Batteries, INDORE and banning for future Business Dealings with MPPKVVCL Indore, in accordance of the provisions of clause No.28 Section-VIII of General Terms & Condition of Purchase of the TS-1532, an opportunity was given to you vide this office show cause letter No. MD/WZ/06/PUR/TS-1532/12693 Indore dated: 14.09.2021, sent to your given email id 'tejabatteries@gmail.com' on dated 14.09.2021 (at 16:45 Hrs.) as well as through registered AD post (the tracking report of the registered post No.RI468208217IN conforms receipt of the same to you on dated 22.09.2021 at 17:14 Hrs.). Thus, you were called upon to explain in writing within a period of 15 days i.e. up 30.09.2021, but no response received from your end within the period stated, therefore in order to have adequate & fair chance to submit your reply, final reminder letter No. MD/WZ/06/PUR/TS-1532/13813 Indore dated: 06.10.2021 was again sent to you on your given email id 'tejabatteries@gmail.com' on dated 06.10.2021 (at 19:02 Hrs.) and the receipt of the same also got vide your return email on dated 06.10.2021 (at 19:02 Hrs.). You were required to submit your justified reply on or before 11.10.2021 up to 11:00 AM but again no response received from your end. Therefore, it is construed that you have nothing to say/submit in this regard and accordingly, MPPKVVCL, Indore proceeded to take the proposed stern actions against your firm in the matter of adoption of the fraudulent practice by your firm.
