AND WHEREAS, you have not complied with the terms & conditions of the aforementioned orders/ extension orders and agreement executed thereof and neither made payment to your deployed workers nor deposited subscription of EPF & ESIC.

AND WHEREAS, for such default repeated reminders/ instructions have been issued by various offices including this office but all in vain. Subsequently, a Performance Evaluation Committee constituted by this office to adjudge your performance for O&M [including watch & ward] of 132 KV Substation Chinnor. Your firm was also given a chance by Committee to submit your stand in the matter twice, but you did not appear before the Committee. Again your firm was requested by this office telephonically and in person for clearing the statutory liabilities of the deployed workers. In response, your firm had assured this office for compliance of statutory defaults [Payment of Minimum Wages to deployed workers and deposition of subscription of EPF & ESIC etc.] and submitting the proofs for the same, but your firm did not bother to make aforesaid statutory payment. Therefore, it was decided earlier to forfeit security deposits submitted by you in most of the above referred locations. Looking to continued willful breach of contract by your firm despite allowing you sufficient time, MPPTCL [being principal employer] had to clear aforesaid statutory payments [Wages + EPF + ESIC] of workers. decided to premature termination of various contracts from December 2019 tc November 2020.

However, before taking action for termination, "Show-Cause Notices' were served upon you vide letter No. 2307000/T&C/SE-II/Tenders/Debar/ 657 dt. 06.11.2020 and 817 dt. 10.02.2021, thereafter reminders were also served vide letter No. No. 2307000/T&C/SE-II/Tenders/Debar/734 dt. 21.12.2020 and 122 dtd. 28.06.2021 to show cause, as to why above mentioned action should not be taken against you. You have submitted reply to the Notice dtd. 06.11.2021 vide your letter No. Nil dtd. Nil was thoroughly examined in the context of factual position and it is found that, you were not adhere to the contractual obligations and it is found that, your firm has grossly failed to adhere to and compliance with the provisions of the tender conditions and your submission given in the Reply to the said Notice does not mitigate consequences on various points of event of statutory defaults.

NOW THEREFORE considering the situation as explained above, it is evident that, you have failed to meet your contractual obligations and finally, under the circumstances, MPPTCL Jabalpur has now decided that in accordance with the Clause-21 of Section-2 of the respective tenders, to debar you from future business dealing with MPPTCL Jabalpur for a period of Three Years from the date of issuance of this order.
