Accordingly, the letter of intent (LOI) vide memo no. Ch-155/COS/T.E.WC-21/Amphs/Voi-I dated 24.12.2018 was issued to your firm against tender enquiry no. WC-21 for epairing of 100 KVA Amorp hous Core damaged distribution transformers for DHBVN against the above said tender enquiry.

Subsequently, on submission of the required Bank Guarantee by your firm, the work order vide memo no. Ch-198/COS/T.E.WC-21/Amphs/Vol-I dated 15.01.2019 was placed upon your firm for repairing of aforementioned ratings distribution transformers as per terms & (एम० देवरा.च conditions of ibid tender enquiry no. WC-21 for a period of one year.

Initially, 200 rao, 100 KVA transformers were allotted to your firm for repairing against which only 75 no. transformers were repaired by your firm against the ibid work order within a period of one year. The clause no. 8 i.e. 'Warranty' of ibid work order, provides as under:

"The repairer shall be responsible to replace free of cost with no transportation and insurance expenses to the purchaser upto the destination of the material, mentioned above the whole or any part of the material which under normal and proper use and maintenance prove, defective in material or work-manship within 24 months from the date of commissioning of the Iransformer by the purchaser or 30 months from the date of receipt of T/F by consignee whichever is earlier provided by the consignee / purchaser gives prompt written notice of such defects to the supplier Such replacement shall be effected by the repairer within a reasonable time not exceeding one month of intim ation of the defects. In case the replacement of defective material is

(पंकज कुनी garried out within 45 days of our intimation of defects, the supplier shall have to pay interest @ per annum of the value of each transformer beginning from the date of its receipt in Store or प्रवच निर्देश per annum of the value of sach transformer beginning from the date of its receipt whichever is later upto the date of its receipt उतार प्रदेश पावर का अध्य विcement / repair or the transformer shall be got repaired from other repairers and the cost so incurred will be recovered from the ist repairer. Supplier's responsibility arising out of supply of material or its use whether in warrantees or otherwise shall not in any case exceed the cost of correcting the defects or replacing the defective parts / material and upon the expiry of the

wananty period stipulated above, all such liabilities shall terminate.

The warranty of a trainsformer shall be for a period of 24 months from the date of commissioning of transformer or 30 months from the date of dispatch of the material which ever expires earlier. In case of transformer repaired within warranty period, the warranty shall be for at least six months from date of re-repair or 30 months from date of original repair/ 24 months from 8(B)

PENALTY IF THE DAMAGED RATE EXCEEDS THE PERMISSIBLE LIMIT:

Penalty will be calculated on the basis of damage rate of transformers with in warranty e period on the completion of the contract. If the damage rate of the transformers repaired by firm exceed the limit as fixed in the contract, following penalty will be imposed.

Further, as per the status supplied by the office of XEN/T&S, DHBVN, Hisar, the damage rate within warranty period of transformers repaired by your firm against above contract was noticed as 34.41% ending 30.04.2021. Accordingly, it was observed that your firm is liable for blacklisting as per above said clause of penalty on excessive damage rate of transformers i.e. being more than 25% within warranty period.

Further in this regard, relevant clause of ibid tender enquiry i.e. clause no. 22.8, 'Procedure for blacklisting of firm' is reproduced as under:

"In case the supplier intends to illegally back out of the commitment, the steps for blacklisting of the firm, besides enforcement of damages recoverable under the law will be taken as per procedure given below:-

- a) A notice shall be served by the purchasing department on the supplier by registered post/speed post bringing his defaults to his notice and asking him to complete all pending supplies / or to settle dispute within a period of 15 days from the date of issue of Notice.
- b) In case the firm fails to comply with the notice(s), a show Cause notice of 21 days shall be issued why the firm/supplier/contractor should not be blacklisted. In the Show Cause Notice complete details of the case, default committed by the firm/supplier/contractor and details of notices issued by the Nigam shall be incorporated.
- c) In case the supplier/firm/contractor fails to comply with the notice issued for blacklisting or does not respond to show cause notice or the reply as submitted is not found justified/convincing. The contract with the firm/supplier shall be terminated inter-alia taking other action as per regulation no. 20 & further the firm may be blacklisted with the approval of BODs.
- d) The period of blacklisting of the defaulting firm/ supplier/contractor will be approved upto 3 years by BOD's and shall be notified to all Power Utilities in the country and the names of such blacklisted supplier/contractor would also be put on the website of the Nigam."

Accordingly the above case was considered by the competent authority of DHBVN in its meeting held on 28.06.2021, wherein it was decided that a 15 days notice of blacklisting may be issued to the firm. In case the firm fails to comply with ibid notice, a second notice of 21 days may be issued to the firm for blacklisting on account of excessive damage rate of transformers, repaired by the firm against contract no. WC-21.

Keeping in view of the above, a notice of 15 days vide memo no. Ch-314/COS/TE WC-21/Amphs/Vol-I dated 29.06.2021 was served upon your firm to submit your reply as to why your firm should not be blacklisted for excessive damage rate of the transformers within warranty period as per provisions of contract no. WC-21. As no reply was received from your firm in response of ibld notice; again a final show cause notice of 21 days regarding blacklisting was served upon your firm vide memo no. Ch-316/COS/TE WC-21/Amphs/Vol-I dated 16.07.2021. It was also intimated to your firm vide ibid notices that in case nothing is heard from your end within stipulated timeline, it shall be presumed that you have nothing to say in your defence and further necessary action for blacklisting of your firm shall be initiated without any further intimation. However, your firm did not respond at all to any of the above said two no. notices. As such, it is ample clear that your firm had nothing to say in the matter.

Now, the above case has been considered by the BODs of DHBVN in its meeting held on 19.05.2022 vide Agenda item no. 193.44, wherein it has been decided to blacklist your firm for a period of 3 years. Accordingly, your firm titled with the name, 'M/s HIndustan Power, 346, HSIIDC Industrial Area, Saha Ambala-133104' is herby blacklisted for a period of 3 years

from the date of issuance of this communication.

This is however without prejudice to other terms & conditions of contract no. WC-
