Dear Sir,

In participation of your firm in auction No. 28140 concluded on 06.12.2022 through M/s MSTC for sale of scrap and unserviceable material available at STPS, MPPGCL, Sarni,, your firm was the H1 bidder against lot No. 3 for 800 MT of M S Scrap. Accordingly sale release order No. 2146 Dtd. 14.03.2023 was issued by STPS, MPPGCL, Sarni to M/s Bharat Steel Traders, Bengaluru and your firm has started lifting of M. S. Scrap since 16.03.2023.

On 22.03.2023, Truck No. KA-01-AH-7710 which was used by M/s Bharat Steel Traders, Bengaluru for delivery of material was captured by local police, with overloading of 13.81 MT. It is pertinent to mention that on dated 21.03.2023 at the time of measurement on weighbridge No.3, the total gross weight of the said vehicle was found 16.060 MT, and the same loaded vehicle when weighted again by the local police, the gross weight of the vehicle was found 29.870 MT. This matter was also investigated by the committee constituted for investigation of the said act, and as per the findings of the committee, the overloading was done by M/s Bharat Steel Traders, Bengaluru carrying the scrap material.

The incidence of overloading by Truck No. KA-01-AH-7710 which was used by your firm for delivery of scrap material clearly indicates indulgence of your firm in unfair activities, which is liable for prescribed proceedings. In accordance with the provision laid down in the clause no. 16.9 Buyer's Specific Terms and Conditions of MSTC your firm is liable for suspension /banning from future business dealing with MPPGCL.

In this regard ,Show cause notice vide No. 342c Jabalpur, dtd. 14/07/2023 was issued to you and an opportunity was given to you to give explanation in writing or present your case in person to the screening committee of MPPGCL as to why MPPGCL should not ban your firm for future business dealing with MPPGCL for a period of three years against the act of over loading of M S Scrap. Accordingly a review meeting with screening committee of MPPGCL and your firm's proprietor was scheduled on dtd. 16/10 /2023. During the presentation/discussion it has been observed by the committee that the Proprietor of firm M/s Bharat Steel Traders, Bengaluru could not submit any satisfactory explanation or evidence regarding non association of his firm in the over loading of M S Scrap at STPS, Sarni on dated 21-03-2023. A written explanation dated 18-10-2023 by email has also been submitted by you were in it is mentioned that some conspiracy has been done against your firm by some local person in association with police and also mentioned that his firm has not taken any extra weight scrap from M.P.P.G.C.L. However, you have not submitted any documentary proof in support of said submission.

In view of above, It has been decided to ban your firm directly or through dealers from all future Business Dealings with MPPGCL for a period of 03 years from the date issue of this letter. Accordingly, no bidding/ documents for any of the Sale/e-Auction/Tender/ enquiry /Enquiries as may be invited either from the Corporate Office or any of the site offices or any other offices of MPPGCL shall be issued and /or award of any work shall be made to you during the said period.

After completion of the period of 03 years, fresh Notification for continuance of Banning or its Revocation may be issued based on the review of the case.
