Subject: Fuel and Power Purchase Adjustment Surcharge (FPPAS) for the month of January, 2026.

Sir,

Hon'ble Commission vide notification dated 26.03.2025 has issued Uttar Pradesh Electricity Regulatory Commission (MYT for Distribution) Regulations, 2025. As per the regulation Fuel and Power Purchase Adjustment Surcharge (FPPAS) has to be charged in nth month for incremental Power Purchase and Transmission Charges paid in n-3th month. Fuel and Power Purchase Adjustment Surcharge (FPPAS) calculated for the month of October, 2025 as per regulation is to be charged in the month of January, 2026.

Accordingly FPPAS has been calculated -2.33% for the month of October, 2025 to be charged in the month of January, 2026. I have been directed to request you to implement the same for all categories of consumers as per provision of the regulation. To comply with the provision of the regulation a detailed calculation sheet is attached for your reference and uploading the same on the website.

- onth month: Month of FPPAS billing, based on tariff changes from (n-3)th month.
- o A: Total power procured in (n-3)th month (kWh).
- o B: Bulk sale of power in (n-3)th month (kWh).
- C: Incremental Average Power Purchase Cost = Actual PPC (Rs./kWh) Approved Average PPC from all sources for the year (Rs./kWh).
- o D: Actual Inter and Intra State transmission charges (n-3)th month (Rs.).
- o E: Base transmission cost = Approved charges/12 (Rs.).
- o Adj Factor: Change in Fuel & Power Purchase Cost for (n-5)th month minus FPPAS recovered in (n-2)th month.
